VISION:

ABOUT THE COMMITTEE:

Grievance Redressal committee was formed to address the grievances of students, faculty, and parents relating to academics, amenities, technology and personal issues, if any, happened within the campus. The main functions of this committee is to address the grievance by the members of the committee, discuss the reasons for grievance and resolve the grievance with resolutions for smooth, fair and transparent functioning of academic activities in the campus. All the grievances are to be addressed are maintained in the form of record.

OBJECTIVES OF THE COMMITTEE:

- To address grievances received from students in order to cater their academic and personal issues within the campus.
- To identify reason of the grievance and resolve the same as early as possible.
- To counsel students and their respective parents as per the grievance committee resolutions.
- To initiate action immediately as and when grievance arises in college to provide emotional and academic support to the students.
- Advising students to respect the right and dignity of all stake holders and show utmost restraint and patience whenever any occasion of conflict arises and report the matter to authority for amenable solutions.

- Minor complaints are solved by the faculties or mentors at the department level for the smooth functioning of the college, but the major complaints which need attention at a higher level are only referred to the grievance committee.
- The Grievance Committee convenes periodic meetings or as and when required to take steps to redress the grievances of students related to academics or non-academics.
- A student or a group of students seeking help of the cell submit an application to the chairperson requesting to hold a meeting with the cell.
- Grievances are collected from the suggestions or complaints boxes in the institute.
- For every week, the suggestion box data will be opened by member of the committee.
- Convener will call for meeting to discuss and address the grievance as quick as possible for the benefit of students, faculty and parents.
- Immediate action plan with resolutions will be derived to promote healthy environment in the campus.
- A report of the meetings is submitted to the Dean's office accordingly.

- To have interactions individually who are involved in the grievance.


BENEFITS:



Standard Operating Procedure (SOP)

Definition of Ragging

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

What Constitutes Ragging?

- Any conduct by words spoken or written or an act which has the effect of teasing, threading or handling with rudeness to a fresher or any other student.
- Financial extortion or act of forceful expenditure.
- Physical abuses.
- Rowdy/undisciplined activities, which cause or are likely to cause annoyance, hardship, physical/psychological harm or fear or apprehension in any student.
- Forcing a student to do an act, which generates sense of shame, torment or embarrassment affecting his/her physique or psyche?
- Any act which prevents/disturbs/disrupts regular academic activities assignment to a student.
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively participating in the discomfiture to fresher or any other student.
- Any act affecting mental health and self-confidence of student with or without any intent to derive a sadistic pleasure showing off power, authority or superiority.

Anti Ragging Cell

Anti-Ragging Cell should be one of the important part of Educational Institution's mechanism. As per the guidelines of UGC under the Act of 1956, which is modified as UGC regulations on curbing the menace of Ragging in higher Educational Institutions, 2009, establishment of Anti-Ragging Cell is very compulsory.

Anti-Ragging Committee is the supervisory and advisory committee in preserving a Culture of Ragging Free Environment in the college Campus. The Committee will be engaged in the works of checking places like Hostels, Buses, Canteens, Classrooms and other places of student congregation, for any incidences of Ragging, and shall educate the students at large in the University about Menace of Ragging and related Punishment Provisions. Committee will also be involved in designing strategies and action plan for curbing the Menace of Ragging in the University by adopting array of activities.

Aim

To root out ragging in all the forms from Dental college campus by prohibiting it by law and preventing its occurrence and punishing those who indulge in ragging according to the appropriate regulations set by Supreme Court and UGC , DCI.

Objectives of Anti Ragging Committee

The main objectives of this cell are as follows:

1. To aware the students of dehumanizing effect of ragging inherent in its perversity.
2. To keep a continuous watch and vigil over ragging so as to prevent its occurrence and recurrence.
3. Promptly and stringently deal with the incidents of ragging brought to our notice.
4. To generate an atmosphere of discipline by sending a clear message that no act of ragging shall be tolerated and any act of ragging shall not go unnoticed and unpunished.
5. To prevent ragging in the College, Hospital, Campus and also take proper action against those whose are indulging into it.
6. To root out ragging in all its forms from the institution by prohibiting it by law and preventing its occurrence by following the provisions of the Regulations of Supreme Court and UGC ,DCI.

Constitution of Anti-Ragging Committee

An anti-ragging committee and an Anti -Ragging Squad is constituted by the head of the institute

The Anti-Ragging Committee includes:-

- The Head of the institution
- Representatives of civil and police administration
- Local media
- Non Government Organizations involved in youth activities (NGO)
- Faculty members
- Parents
- Warden (Girls & Boys Hostel)
- Students belonging to the fresher's category as well as seniors
- Non-teaching staff

It shall monitor the Anti Ragging activities in the institution, consider the recommendations of the Anti-Ragging Squad and take appropriate decisions, including spelling out suitable punishments to those found guilty.

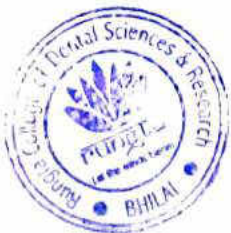
Functions of the Anti-Ragging Committee


1. The committee will monitor carefully any ragging incidences in the college premises, canteen, college buses, mess area and hostels through frequent raids by anti ragging squad.
2. To monitor an undertaking in the prescribed format from the candidate concerned on anti-ragging at the time of admission.
3. To address the students and parents by the head of the institutions on antiragging committee.
4. Awareness parents, guardians of the students is created at the time of Dean's address and PTM throughout the academic year.
5. To form monitoring cells (Anti-ragging squad's faculties for surprise raids).
6. To suggest measures to tighten the security.

The Anti-Ragging Squad:-

The Functions of Anti Ragging Squad will be to keep a vigil and stop the incidences of Ragging, if any, happening/reported in the places of Student aggregation including, Classrooms, Canteens, Buses, Grounds, Hostels etc.

The Squad will also educate the students at large by adopting various means about the Menace of Ragging and related Punishments thereto.

A gamut of positive reinforcement activities will have to be adopted by Anti-Ragging Squad for orienting students and molding their personality for a better cause.

Squad consists of members belonging to the various sections of the campus community.

Functions of Squad

1. The Squad shall have vigil, oversight and patrolling functions.
2. It shall be kept mobile, alert and active at all times and shall be empowered to inspect places of potential ragging and make surprise raids on hostels and other hot spots.
3. The Squad shall investigate incidents of ragging and make recommendations to the Anti-Ragging Committee
4. Squad will work under the overall guidance of the Anti-Ragging Committee

As per the order of Supreme Court of India and subsequent Notification from University Grants Commission (UGC), ragging constitutes one or more of any intention by any student or group of students on:

1. Any act of Indiscipline, Teasing or Handling with Rudeness.
2. Any act that Prevents, Disrupts the Regular Academic Activity.
3. Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
4. Any Act of Financial Extortion or Forceful Expenditure.
5. Any Act of Physical Abuse causing Assault, Harm or danger to Health.
6. Any Act of abuse by spoken words, emails, SMS or public insult etc.
7. Any Act of injury or infringement of the fundamental right to the human dignity.
8. Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
9. Any unlawful assembly or conspiracy to ragging.

Punishment to those found guilty

Any student or group of students found guilty of ragging in the campus or even outside the campus shall be liable to one or more of the following punishments

1. Debarring from appearing in any sessional test / University Examination
2. Suspension from attending classes and academic privileges
3. Withdrawing scholarships and other benefits
4. Suspension from the college
5. Cancellation of the admission
6. Withholding the results.
